

Arize Lucky Draw Scheme

Terms and conditions applicable for the Arize Lucky Draw Scheme (“Scheme”)-

1. This Scheme is being conducted by Bayer CropScience Limited (“Bayer) from 10th May 2019 to 31st July 2019 (“offer period”)
2. This Scheme is only on all Arize hybrids and all packs.
3. The Scheme is subject to availability of Arize packs in the market. Bayer is not liable if the stocks of the products are not available at the retailer in any areas where the Scheme operates.
4. The prizes under the Scheme will be declared through instant SMS (for Motorbikes & wall clocks) and on Bayer website for A for Arize Scholarship winners.
5. All major individuals are eligible to participate in this Scheme, subject to the terms and conditions set out herein, which will be presumed to have been accepted by him/her.
6. One can get an opportunity to participate in this Scheme by sending label number or QR code number mentioned on the back side of all Arize packs to the number 7353 63 6444 (label No) or 9167500000 (QR code) by an SMS. The last date for sending SMS is 31st July 2019.
7. Sending label number at 7353 63 6444 or QR code no at 9167500000 by an SMS and registering an entry in accordance with the aforesaid instructions does not confer upon the sender any right to win any prize under the Scheme .
8. From the registered entries received under the Scheme, vide pre- defined algorithm and vide random sampling by computer (for second label draw of A for Arize scholarships); entries will be selected for different prizes. Bayer does not have any discretion, choice or hand in the selection process.
9. Each winner will be entitled to only one prize, regardless of the fact that the winner may have sent more than one entry.

A for Arize Scholarship winners are to be selected based on lucky draw post registration of shortlisted farmers and fulfilment of separate criteria laid down for the same (i.e. applicable for those farmers having school/ college going child).
